By-law No. 14-2020 Waste, Compost & Disposal and Recycling Services - \$163.48 levy for collection and disposal of solid waste and recycling.

If you are paying using your debit card, please ensure your daily security limit is high enough to process the payment.

If not paid by the due date, outstanding balances are subject to a penalty of 1.25% per month, added on the 1st day of each month until paid.

New Construction

If you have recently constructed or removed a taxable building, a supplemental tax notice will be mailed to you at a later date.

Depending on the completion date of the construction you may receive a tax bill for both the previous and current year.

If you are eligible to receive the EPTC, contact our office any time throughout the year.

- Homeowners who notify our office before the printing of the property tax statement for the year, the EPTC will be applied to the statement of that tax year.
- Homeowners who notify our office after the printing of the tax statement will have to claim the EPTC on their personal tax return for that year and will receive the EPTC on their property tax statement in following years.
