Taxes are due by August 29, 2025, at 4:30 p.m.

### **Payment Options**

• In-Person Payments at 100-195 Stephen Street

Cash, cheque, and debit. Please ensure your debit card has a sufficient daily transaction limit. Credit cards are **NOT** accepted.

#### Online Bank Payments

Online payments may take up to three business days to process. To avoid a late payment, we recommend you make your online payment by August 26, 2025. Payments received by the City of Morden after the due date are subject to penalties beginning September 1.

Pre-Authorized Payment Plan

Applications may be obtained at the Civic Centre office or by emailing us at <a href="mailto:info@morden.ca">info@morden.ca</a>. The due date remains August 29, 2025, and penalties are applicable to overdue accounts.

# **After-Hours Payment Drop-off**

A secure deposit box is available at the Civic Centre front entrance for cheque payments during business and non-business hours. To avoid late penalties, please have your payment in the deposit box by 4:30 pm on August 29, 2025.

# **Penalty Notice**

A penalty of **1.25% per month** will be applied to any unpaid balance beginning **September 1**, and on the first day of each month thereafter until the balance is paid in full.

# **Update Your Contact Information**

Please notify our office of any changes to your phone number, email, or mailing address.

If you receive a tax bill for a property you no longer own, kindly forward it to the new owner or notify us.

#### **New Construction or Demolition**

If you have recently constructed or removed a taxable building, a **supplemental tax notice** will be issued. Depending on the completion date, you may receive bills for both the current and previous year.

# New! Homeowners Affordability Tax Credit (HATC)

The Education Property Tax Credit (EPTC) is being replaced by the Homeowners Affordability Tax Credit (HATC)

- Increased to a maximum of \$1,500.00.
- Applies only to primary residences.
- Not applicable to rental properties, secondary residences, cottages, or commercial properties.
- Farm properties will continue to receive a 50% rebate on gross school taxes.
- The commercial property school tax rebate has been discontinued starting in 2025.
